This has reference to our Notice Inviting Expression of Interest (EOI) dated 08.01.2020 and your response in this regard dated 03.02.2020.

We are pleased to inform you that; your firm has been empanelled with Maharashtra Rail Infrastructure Development Corporation Limited (MRIDC) as a RDSO approved Firm for "Fabrication, Supply and Launching of Composite and other Steel Plate Girders as well as Open Web Steel Girders and Bow String Girders" for a period of 1 year i.e. from 18.09.2020 to 17.09.2021 subject to the following:

1. This Empanelment with MRIDC is conditional and may be withdrawn any time, if the performance is found to be unsatisfactory or if you sublet any work of Fabrication, Supply and Launching of Steel Girders awarded to you.
2. This Empanelment with MRIDC will be cancelled automatically if the name of Firm / Agency is removed from the approved list of RDSO.

This deposit will be retained with MRIDC till validity period of Empanelment for being eligible for participation in Tenders floated by MRIDC for subject works.
5. Please note that this is Empanelment only and not the award of any work. The work shall be awarded through Limited Bidding and Selective Tendering process by MRIDC.
